

FORD MOTOR COMPANY Lifetime Limited Warranty on Bedliners

Ford Motor Company (Ford) warrants your Bedliner to be free from defects in material and workmanship for as long as you own the vehicle in which the Bedliner was originally installed (herein the "Warranty Period") and further subject to the conditions below.

If your Bedliner fails because of a defect in material or workmanship during the Warranty Period, the original purchaser shall notify the dealer from whom the Bedliner was purchased.

FURTHER CONDITIONS OF WARRANTY AND WARRANTY CLAIM PROCEDURE:

This warranty extends only to the original purchaser of the Bedliner.

In order to make a claim under the warranty, the original purchaser shall notify Ford of the following: purchaser's name and address, the date of purchase, the location at which the Bedliner was purchased and a description of the claimed defect.

After receipt of notification of claimed defect, Ford agrees to examine, within 30 days, the Bedliner alleged to be defective. The purchaser must present the vehicle to a Ford dealership for examination. If, in Ford's judgment, the Bedliner is defective in factory-supplied materials or workmanship, then Ford will either repair or replace, at its sole discretion, the defective Bedliner. If Ford believes that the Bedliner examined does not have a defect in either material or workmanship caused by Ford, then Ford shall furnish the purchaser with a written denial of claim.

THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU MAY HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE. THIS WARRANTY IS THE ONLY EXPRESS WARRANTY APPLICABLE TO YOUR BEDLINER. FORD NEITHER ASSUMES NOR AUTHORIZES ANYONE TO ASSUME FOR IT ANY OTHER OBLIGATION OR LIABILITY IN CONNECTION WITH YOUR BEDLINER OR THIS WARRANTY.

FORD AND YOUR DEALER ARE NOT RESPONSIBLE FOR ANY TIME THAT YOU LOSE, FOR ANY INCONVENIENCE YOU MIGHT BE CAUSED, FOR THE LOSS OF YOUR TRANSPORTATION, OR FOR ANY OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES YOU MAY HAVE.

YOU MAY HAVE SOME IMPLIED WARRANTIES. FOR EXAMPLE, YOU MAY HAVE:

- □ AN IMPLIED WARRANTY OF MERCHANTABILITY (THAT YOUR BEDLINER IS REASONABLY FIT FOR THE GENERAL PURPOSE FOR WHICH IT WAS SOLD);
- □ AN IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE (THAT THE BEDINER IS SUITABLE FOR SPECIFIC PURPOSES).

THESE IMPLIED WARRANTIES ARE LIMITED, TO THE EXTENT ALLOWED BY LAW TO THE TIME PERIOD COVERED BY THE WRITTEN WARRANTIES, OR TO THE APPLICABLE TIME PERIOD PROVIDED BY STATE LOW, WHICHEVER PERIOD IS SHORTER.

SOME STATES DO NOT ALLOW FORD TO LIMIT HOW LONG AN IMPLIED WARRANTY LASTS OR TO EXCLUDE OR LIMIT INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE LIMITATION AND EXCLUSIONS DESCRIBED ABOVE MAY NOT APPLY TO YOU.

This warranty herein does not apply and Ford assumes no responsibility for any damage or defect that may be due to any one or more of the following:

□ Improper installation of a Bedliner.

OR

- Unreasonable use, including the failure to provide reasonable and necessary maintenance.
- D Modification or alteration of a Bedliner in a manner which increases its susceptibility to damage.
- □ In any case where the Bedliner has been misused or intentionally damages.
- □ In any case where the Bedliner has been damaged as a result of a motor vehicle accident or other type of accident.
- □ In any case where the Bedliner has been repaired by other than an authorized Ford Dealer.
